## ਰੈਗੂਲੇਟਰੀ ਤਬਦੀਲੀਆਂ - ਕਮਿਸ਼ਨਰ ਦਾ ਰੇਟ ਬਾਰੇ ਆਰਡਰ

ਬੀ ਸੀ ਦੀ ਸਰਕਾਰ ਨੇ ਰੈਗੂਲੇਟਰੀ ਤਬਦੀਲੀ ਕੀਤੀ ਹੈ ਜਿਹੜੀ ਲੋਅਰ ਮੇਨਲੈਂਡ ਦੇ ਟਰੱਕਿੰਗ ਸੈਕਟਰ `ਤੇ ਅਸਰ ਪਾਵੇਗੀ।

1 ਜੁਲਾਈ, 2019 ਤੋਂ *ਕਨਟੇਨਰ ਟਰੱਕਿੰਗ ਰੈਗੂਲੇਸ਼ਨ* ਦੀਆਂ ਰੇਟਾਂ ਦੀਆਂ ਸ਼ਰਤਾਂ ਖਤਮ ਕਰ ਦਿੱਤੀਆਂ ਜਾਣਗੀਆਂ, ਅਤੇ ਕਨਟੇਨਰ ਟਰੱਕਿੰਗ ਕਮਿਸ਼ਨਰ ਕੋਲ ਰੇਟ ਤੈਅ ਕਰਨ ਅਤੇ ਫਿਉਲ ਸਰਚਾਰਜ ਲਾਉਣ ਦਾ ਅਧਿਕਾਰ ਹੋਵੇਗਾ।

ਕਨਟੇਨਰ ਟਰੱਕਿੰਗ ਐਕਟ ਦੇ ਸੈਕਸ਼ਨ 22 ਮੁਤਾਬਕ, ਨਾਲ ਲੱਗਾ ਆਰਡਰ ਘੱਟੋ ਘੱਟ ਰੇਟ ਤੈਅ ਕਰਦਾ ਹੈ ਜਿਹੜੇ ਕਿ 1 ਜੁਲਾਈ, 2019 ਤੋਂ ਕਨਟੇਨਰ ਟਰੱਕਿੰਗ ਦੀਆਂ ਸੇਵਾਵਾਂ ਦੇਣ ਵਾਲੇ ਸਾਰੇ ਲਸੰਸਧਾਰੀਆਂ ਵਲੋਂ ਦਿੱਤੇ ਜਾਣੇ ਜ਼ਰੂਰੀ ਹਨ। ਨਾਲ ਲੱਗੇ ਆਰਡਰ ਵਿਚ ਪੋਜ਼ੀਸ਼ਨਿੰਗ ਮੂਵਮੈਂਟ ਰੇਟ ("ਪੀ ਐੱਮ ਆਰ") ਦਾ ਅਰੰਭ ਸ਼ਾਮਲ ਹੈ ਜੋ ਕਿ ਅਦਾਇਗੀ-ਰਹਿਤ ਪੋਜ਼ੀਸ਼ਨਿੰਗ ਮੂਵਜ਼ ਲਈ ਇਵਜ਼ਾਨਾ ਦੇਣ ਲਈ ਸਾਰੇ ਔਨ ਜਾਂ ਔਫ-ਡੌਕ ਟ੍ਰਿਪ ਰੇਟ ਪੇਮੈਂਟਾਂ ਵਿਚ ਪਾਇਆ ਜਾਵੇਗਾ।

ਲਸੰਸੀਆਂ ਨੂੰ ਡਰਾਈਵਰਾਂ ਦੀ ਤਨਖਾਹ ਦੀਆਂ ਸਾਰੀਆਂ ਢੁਕਵੀਂਆਂ ਸਟੇਟਮੈਂਟਾਂ ਉੱਪਰ ਪੀ ਐੱਮ ਆਰ ਦੀ ਪਛਾਣ ਕਰਨੀ ਪਵੇਗੀ ਅਤੇ ਇਸ ਦਾ ਵੱਖਰਾ ਹਿਸਾਬ ਲਾਉਣਾ ਪਵੇਗਾ। ਆਫਿਸ ਔਫ ਦਿ ਬੀ ਸੀ ਕਨਟੇਨਰ ਟਰੱਕਿੰਗ ਕਮਿਸ਼ਨਰ ("ਓ ਬੀ ਸੀ ਸੀ ਟੀ ਸੀ") ਆਉਂਦੇ ਮਹੀਨਿਆਂ ਵਿਚ ਆਡਿਟ ਕਰੇਗਾ ਤਾਂ ਜੋ ਇਹ ਪੱਕਾ ਹੋਵੇ ਕਿ ਲਸੰਸੀ ਨਵੀਂਆਂ ਸ਼ਰਤਾਂ ਦੀ ਪਾਲਣਾ ਕਰ ਰਹੇ ਹਨ।

ਇੰਡਸਟਰੀ ਦੀਆਂ ਹਿੱਤ ਰੱਖਣ ਵਾਲੀਆਂ ਧਿਰਾਂ ਨਾਲ ਸਲਾਹ-ਮਸ਼ਵਰੇ ਤੋਂ ਬਾਅਦ, ਬੀ ਸੀ ਦੀ ਸਰਕਾਰ ਨੇ ਇਹ ਐਲਾਨ ਕੀਤਾ ਸੀ ਕਿ ਉਹ ਪੀ ਐੱਮ ਆਰ ਨੂੰ ਲਾਗੂ ਕਰਨ ਦੀ ਹਿਮਾਇਤ ਕਰੇਗੀ, ਜਿਸ ਦੀ ਸਿਫਾਰਸ਼ ਕਮਿਸ਼ਨਰ ਨੇ ਆਪਣੇ 2018 ਦੇ ਰੇਟ ਰਿਵੀਊ ਵਿਚ ਕੀਤੀ ਸੀ।

# **INDEPENDENT OPERATORS (I/Os)**

#### **INDEPENDENT OPERATORS PAID HOURLY**

#### **MINIMUM RATES**

#### **Hourly Rate**

\$52.46 per hour if an I/O has performed less than, and \$53.66 per hour if an I/O has performed more than (or equal to), 2340 collective hours of container trucking services for any licensees (hourly rates are inclusive of benefits)

(If an independent operator performs container trucking services by employing an indirectly employed operator, the amount owed by the licensee to the independent operator is reduced by the amount that licensee pays the indirectly employed operator)

#### Callout

\$300 or the applicable hourly rate, whichever is greater, if an independent operator agrees, at the request of a licensee, to be available to perform container trucking services for 4 or more continuous hours in a 24-hour period

#### **Fuel Surcharge**

See fuel surcharge section below

#### **INDEPENDENT OPERATORS PAID BY THE TRIP**

#### **MINIMUM RATES**

#### On-Dock Trip Rate\*

See On-Dock rate schedule – Appendix II

#### Off-Dock Trip Rate\*

See Off-Dock rate schedule - Appendix III\*\*

\*\*The amount set out in the applicable destination area (column 2) opposite the applicable origin area (column 1) if the I/O moves one container, and 1.5 times the same amount if the I/O moves two containers

(If an independent operator performs container trucking services by employing an indirectly employed operator, the amount the licensee must pay the independent operator is reduced by the amount, if any, that the licensee pays the indirectly employed operator)

#### **Positioning Movement Rate**

\$25 per on or off-dock trip rate payment if the I/O moves 1 container on a single chassis, and 1.5 times the same amount if the I/O moves 2 containers using multiple chassis. (Licensees are required to identify and separately account for the positioning movement rate payment on all eligible driver pay statements)

#### **Callout**

\$300 or the applicable rate per trip, whichever is greater, if an independent operator agrees, at the request of a licensee, to be available to perform container trucking services for 4 or more continuous hours in a 24-hour period

#### **Fuel Surcharge**

## **DIRECTLY EMPLOYED OPERATORS**

#### **MINIMUM RATES**

#### **Hourly Rate**

\$26.30 per hour if a directly employed operator has performed less than, and \$27.50 per hour if a directly employed operator has performed more than (or equal to), 2340 collective hours of container trucking services for any licensee or licensees (hourly rates are inclusive of benefits)

#### Callout

No less than 4x the applicable hourly rate if a directly employed operator agrees, at the request of a licensee, to be available to perform container trucking services for 4 or more continuous hours in a 24-hour period

### INDIRECTLY EMPLOYED OPERATORS

#### MINIMUM RATES

#### **Hourly Rate**

The difference, if any, between the amount paid by the I/O to the indirectly employed operator and the applicable hourly rates for directly employed operators if an I/O employs an indirectly employed operator to perform container trucking services on behalf of a licensee

#### **Callout**

The difference, if any, between no less than 4x the applicable hourly rate and the amount paid by the I/O to the indirectly employed operator, if an indirectly employed operator agrees, at the request of a licensee or an independent operator performing container trucking services on behalf of a licensee, to be available to perform container trucking services for 4 or more continuous hours in a 24 hour period

## **FUEL SURCHARGE**

"quarter" means one of the following:

- a) January 1 to March 31;
- b) April 1 to June 30;
- c) July 1 to September 30;
- d) October 1 to December 31;

"reference price of diesel" means the lower of the following:

- a) the average retail price per litre, including taxes, of diesel in Vancouver as reported by the Kent Group for the quarter immediately before the date on which a fuel surcharge is calculated, rounded down to the nearest \$0.05;
- b) if an independent operator obtains diesel at a discount from the ordinary retail price for the purposes of providing container trucking services, the amount paid per litre by the independent operator, rounded down to the nearest \$0.05.

#### **Fuel surcharge formula:**

In each calendar month, if the reference price of diesel for an independent operator is more than \$1.05, a licensee must pay the independent operator a fuel surcharge, calculated in accordance with the following formula:

where:

A = the reference price of diesel, in dollars;

B = the minimum compensation payable by the licensee to the independent operator in that month, as determined by the required rate payment (exclusive of the positioning movement rate), in dollars.
