

Message from the Container Trucking Commissioner

The Office of the BC Container Trucking Commissioner (OBCCTC) had an active and productive Fiscal 2019/20 (April 1, 2019 to March 31, 2020) as it continued to fulfill its mandate to administer and enforce the *Container Trucking Act* (the *Act*), *Container Trucking Regulation* (the *Regulation*) and Container Trucking Services Licence (the Licence) in order to stabilize the Lower Mainland container trucking industry.

This year, the OBCCTC completed 18 audits, issued 23 decisions and 1 order all culminating in \$3.57M paid to truckers since 2015.

Rate setting became the responsibility of the Commissioner this year. The Rate Order of the Container Trucking Commissioner came into effect on July 1, 2019, which set the minimum rates that must be paid by Licence holders. The OBCCTC implemented four subsequent changes to the rates which included the introduction of the Positioning Movement Rate, amendments to the fuel surcharge formula, phased increases to the hourly rate and new zone definitions with new trip zone rates.

To prepare for the 2020 Container Trucking Services Licence, the OBCCTC consulted with stakeholders from November 2019 through February 2020 concerning proposed changes to the Licence application process and the Truck Tag Management Policy. A final consultation report summarizing what we heard was published in February 2020. The reform measures encourage greater regulatory compliance, promote the efficiency, effectiveness and competitiveness of the Lower Mainland drayage sector and assist in facilitating the professionalization of the industry through reinforcement of ethical business practices, accurate record keeping processes and payroll systems. However, the licencing process came to a halt amidst the COVID-19 pandemic, and the term of the 2018 licence was extended to November 30, 2020.

Industry communications continues to be an important aspect of the OBCCTC's relationship management with members of the drayage industry. A Communications Officer was hired in February 2020 to manage and improve the OBCCTC's communications channels. A newsletter summarizing office activities is published quarterly, while monthly updates are emailed to all stakeholders, including Independent Operators. The office received over 2,520 phone calls from drivers this fiscal year and continues to focus on direct engagement with drivers in order to meet its goal of increasing driver knowledge of OBCCTC activities and the regulatory regime. I expect further growth and improvements to our communication networks in the upcoming year.


The OBCCTC is committed to practice, procedure and policy development as well as enforcement that assists in advancing the drayage sector towards greater compliance,

Outreach

In addition to regular Industry Advisory Committee meetings and bulletins, the OBCCTC publishes a quarterly newsletter intended to provide industry stakeholders with updated information regarding OBCCTC policy and audit/enforcement activities. Monthly Updates are also emailed, which summarize the office's activities from the previous month. The update is issued to all interested stakeholders, including drivers, through an email distribution list.

The OBCCTC website serves as the OBCCTC's primary communication portal and updates are ongoing to the website. OBCCTC communications continue to be issued in English and Punjabi as required, with both versions posted on the website: http://obcctc.ca

Rate Setting Responsibility

In July 2019, the Government of British Columbia repealed the rates and remuneration provisions of the *Regulation*, and gave authority to the Container Trucking Commissioner to set rate and fuel surcharges. This was done to help maintain stability, fairness and competitiveness in the drayage sector.

Rate Order of Commissioner

The Rate Order of the Container Trucking Commissioner came into effect on July 1, 2019. The Order set the minimum rates that must be paid by all CTS Licence holders.

The following rate changes were implemented:

Positioning Movement Rate

The commissioner introduced a \$25 Positioning Movement Rate that was added to all on or off-dock trip rate payments in order to compensate drivers for previously unpaid positioning moves.

Fuel Surcharge

The fuel surcharge formula was amended to account for an average monthly calculation of diesel prices in Vancouver, BC. The fuel surcharge is posted each month on the OBCCTC website.

Increase to Hourly Rate

Phased increases to the base hourly rate for Independent Operators was implemented, with the first initial increase of 10% set to occur on April 1, 2020.

Trip Rate Zones

The zone definitions were amended, and new corresponding zone rates. Long distance trip rates are also set to be increased. Booklets containing the new trip rates were made available to drivers and is also available on the OBCCTC website. These changes are set to be effective on April 1, 2020.

Rate Zone Map

An interactive online Rate Zone Map was built and shows the new rate zones across the Lower Mainland along with designated trip rates for each zone. Users can search for an address to find corresponding trip rates. The map can be accessed through the OBCCTC website.

CTS Licence Reform

The OBCCTC proposed a series of licence reforms to encourage greater regulatory compliance, promote the efficiency, effectiveness and competitiveness of the Lower Mainland drayage sector and facilitate the professionalization of the industry through reinforcement of ethical business practices, accurate record keeping processes and payroll systems.

On September 25, 2019, the OBCCTC began consulting with stakeholders concerning proposed changes to the current Licence and application process. The proposed reform measures were published on November 12, 2019 in a consultation paper. A supplemental consultation paper was published on February 11, 2020 to introduce new proposals and expand upon previous recommendations.

Stakeholders provided feedback in response to the proposals through written submissions, Industry Advisory Committee meetings, focus groups and consultation sessions which concluded on February 28, 2020. A final consultation report summarizing responses heard from stakeholders was published on March 5, 2020.

Licence reforms:

- The current 5 truck minimum licence criteria remains.
- Joint licence applications to not be accepted; however, 2018 CTS Licence joint licensees are permitted to apply for a single licence even if their fleet size is less than 5 trucks, provided they satisfy all remaining mandatory licensing requirements.
- The target range for number of truck tags issued is 1450-1550.
- Licences to be issued on a 2-year term.
- New applicants can apply for a licence but will only be considered after existing licensee applications are reviewed and if there are remaining truck tags.
- Allocation of company and independent operator (I/O) truck tags for existing licensees to be determined by assessing an applicant's business case, compliance history and fleet efficiency data. For new applicants, only the business case to be assessed.
