Goodrich Transport Ltd. (CTC Decision No 06/2023) - Decision Notice

On December 1, 2022, the Office of the BC Container Trucking Commissioner participated in an enforcement initiative and a truck operated by Goodrich Transport Ltd. ("Goodrich") was observed performing container trucking services without a truck tag. On December 15, 2022, the Office of the BC Container Trucking Commissioner ("OBCCTC") invited Goodrich to provide a submission and requested payroll records to determine if Goodrich was compliant with the sections 22 and 23 *Container Trucking Act* ("Act) and sections 6.15 and 6.16 of the Container Trucking Services licence ("CTS Licence").

In <u>Goodrich Transport Ltd.</u> (CTC Decision No 06/2023), I was determined that Goodrich had paid the driver the required minimum rates pursuant to section 24 of the *Container Trucking Regulation* (the "*Regulation*"); however, I found Goodrich had violated section 6.15 and 6.16 of the CTS Licence and determined that this was an appropriate case to issue a penalty for the reasons set out in paragraphs 20-29. I proposed to impose an administrative fine against Goodrich in the amount of \$1,000.00. Consistent with s. 34(2) of the Container Trucking Act, I advised Goodrich that I would consider its written response to the proposed penalty if it was received within 7 days.

Goodrich has not provided a written response within the time specified in the notice.

In the result, I hereby order Goodrich to pay an administrative fine in the amount of \$1,000.00. Section 35(2) of the *Container Trucking Act* requires that this fine be paid within 30 days of the issuance of this Notice. Payment should be made by delivering to the Office of the BC Container Trucking Commissioner ("OBCCTC") a cheque in the amount of \$1,000.00 payable to the Minister of Finance.

Finally, I note that Goodrich may request a reconsideration of the Commissioner's Decision by filing a Notice of Reconsideration with the Commissioner not more than 30 days after Goodrich's receipt of this Decision Notice. A Notice of Reconsideration must be:

- a. made in writing,
- b. identify the decision for which a reconsideration is requested,
- c. state why the decision should be changed,
- d. state the outcome requested,
- e. include the name, an address for delivery, and telephone number of the applicant and, if the applicant is represented by counsel, include the full name, address for delivery and telephone number of the applicant's counsel,
- f. signed by the applicant or the applicant's counsel.

Despite the filing of a Notice of Reconsideration, the above orders remain in effect until the reconsideration application is determined.

This decision notice along with the commissioner decision will be published on the Commissioner's website.
